# Risk Assessment Summary of Control Measures

## Facilities Risk Assessment

<b>Fire</b>	Conforms to Victoria Fire Standards – fixed wired smoke alarms, evacuation procedure, extinguishers, inspections & checks
<b>Security</b>	Lockable doors, duty management at night, authorised visitors, staff uniform, 24-hour PGL staff presence
<b>Buildings</b>	Comply with standard Facilities Management requirements e.g. fire, building regs, legionella, asbestos register
<b>Catering</b>	Complies with Victoria Food Safety Program; encourage healthy diet
